Dumpster Permits - Roll off containers	\$100.00 fee, per 30 days. Deposit of \$500, plus appropriate insurance.
Moving Buildings over Public Highways	\$115.00, plus appropriate insurance.
Paving	\$115.00/first 100 ft. plus \$115 for each add'l. 100 ft. or part thereof.
Placing Material in Street/Public Area	\$100.00 fee. Deposit of \$500, plus appropriate insurance.
Sanitation Fee-Commercial***	\$5.00 per excess pickup
