APPROVE MINUTES OF SPECIAL MEETING OF AUGUST 20, 2015.

1. **DEFERRED AGENDA.**

Parking on Meadow Street and Meadow Place.

Commissioner Kenneth Jackson reviewed the area with Chris Markin, Craig Bandini and other Police Personnel. It is their recommendation to allow parking on the west side of Meadow Place from the driveway to Main Street. This will add several spaces. There is parking available on the east side of the road with the exception of the front of 2 houses where there is No Parking 8am-6pm. The majority of the available spacing on the east side of Main Street falls under the jurisdiction of the Village of Hempstead. They spoke with the Hempstead Police Department Traffic Lieutenant who states that their No Parking signs were erected recently due to the heavy commercial traffic in the area as well as the new apartment house. It is his opinion that these signs will remain, however, if we wish consideration to allow parking, the Garden City Traffic Commission may address a letter stating same to him and he will present it to the Hempstead Traffic Commission.

DECISION: The Traffic Commission at its meeting of August 20, 2015 approved removing parking restrictions on west side of Meadow Place from driveway to Main Street. Also, Trustee Robert Bolebruch to send letter to Hempstead Village to remove the parking restrictions on the north side of Main Street from the Village of Garden City line to Meadow Place.


LETTER TO VILLAGE OF HEMPSTEAD TRAFFIC COMMISSION.
