CRITERIA FOR APPROVAL OF BLOCK PARTY

- 1. Block parties will not be authorized on streets classified as a major intermediate or collector street.**
- 2. Not more than one block party will be authorized for the same block in any calendar year.**
- 3. All block parties shall terminate not later than 11:00 p.m.**
- 4. The letter of application shall include the assurance that all residents on the block have been canvassed.**
- 5. At least 75% of the residents on the block are to be included on the letter of request.**
- 6. Music, if any, shall be kept at a low key in consideration of neighboring residents.**
- 7. Permission will be denied if opposition is expressed to the granting of a permit by a resident of the block because of illness in the family, provided a statement is furnished to the Village by the attending physician that the annoyance could be injurious.**
- 8. It shall be the responsibility of the residents of the block to insure that the street area is free of any litter following the block party.**
- 9. A permit fee of \$75.00 (nonrefundable) to cover the manpower and trucking costs of delivery and pickup of the barricades shall accompany the application.**
- 10. In the event alcoholic beverages will be consumed, application must contain a statement as to the number of people expected to participate, that the applicant(s) agree to assume full responsibility for supervising the conduct of the participants and will take adequate precautions to ensure that minors will not be served or allowed to consume alcoholic beverages.**
