- LEAVES AND YARD WASTE MAY NOT BE BLOWN ONTO VILLAGE STREETS.
- THERE IS NO DUMPING ALLOWED ON VILLAGE STREETS OR VILLAGE PARKLAND.
- DURING THE VILLAGE'S LEAF PICK-UP SERVICE PERIOD, LEAVES MAY ONLY BE PLACED ON THE VILLAGE'S RIGHT OF WAY BETWEEN THE PRIVATE PROPERTY OWNER'S PROPERTY LINE AND THE CURB, PROVIDED THAT SIDEWALKS MUST BE MAINTAINED CLEAR OF LEAVES. BRANCHES ARE NOT TO BE INCLUDED WITHIN LEAF PILES. PLEASE CHECK WITH THE VILLAGE PUBLIC WORKS OFFICE AND VILLAGE WEBSITE AS TO THE DATES OF THE VILLAGE'S LEAF PICK-UP SERVICE PERIOD AS THEY ARE SUBJECT TO CHANGE.
- LANDSCAPERS MUST COMPLY WITH THE RULES AND REGULATIONS OF THE VILLAGE OF GARDEN CITY.
- EVERY LANDSCAPER VEHICLE USED IN THE VILLAGE MUST HAVE A VILLAGE OF GARDEN CITY DECAL ON THE LEFT FRONT BUMPER OF EACH VEHICLE AND LEFT REAR BUMPER OF ANY TRAILER.
