

**4/29/25**

- Officers responded to a residence for a domestic incident and, upon investigation, arrested a male subject for injuring the wrist of a female family member and threatening to kill her. He was charged with assault and menacing.
- Upon investigation at a local bank, Officers arrested a male subject for using false identification without authorization in an attempt to fraudulently transfer funds from a victim's bank account to another account.
