

**9/09/25**

- A joint operation between the Garden City Police Department and the Nassau County Probation Department resulted in the arrest of three subjects for driving with licenses revoked for Driving While Intoxicated.
- The Department is investigating a report of threatening text messages being sent to a local business.
- A ring was reported lost or stolen in the vicinity of Dartmouth Street.
