Brief Description of Proposed Action (include purpose or need): The proposed action consists of a site plan approval and change of zone from the R-T Residential Townhouse Zoning District to permit multi-family residential with a special use permit, and subsequent construction of a 194,033± square-foot, two- to four-story, 150-unit multi-family residential building with a fifth floor penthouse to be used as an exercise facility (proposed project) at 555 Stewart Avenue in the Incorporated Village of Garden City, Nassau County, New York (subject property, see attached Site Location Map). The residential building would include 135 market-rate rental units and 15 affordable rental units, consisting of 20 one-bedroom, 115 two-bedroom and 15 three-bedroom units, a 4,864± square-foot exercise facility and 24-hour doorman service. Access to the site would be provided via proposed curb cuts (one ingress and one egress) along Stewart Avenue. Proposed parking would include 44 at-grade (off-street) parking stalls and 292 subsurface parking stalls. The 4.45±- acre subject property currently consists of a vacant paved lot with minimal overgrown vegetation. The proposed action aims to address the need for quality rental housing that would be targeted to empty-nesters and young professionals. Additionally, the proposed action would conform to the Village of Garden City Affordable Housing statute.


