GARAGE/TAG SALE REGULATIONS

1. PERMIT MUST BE OBTAINED AT LEAST FIVE (5) BUSINESS DAYS IN ADVANCE OF THE PROPOSED SALE FROM THE VILLAGE CLERK FOR A FEE OF \$30.00.
2. NOT MORE THAN ONE (1) PERMIT MAY BE ISSUED TO ONE (1) PERSON AT ONE (1) LOCATION DURING A TWELVE (12) MONTH PERIOD EXCEPT THAT A SECOND SALE MAY IMMEDIATELY PRECEDE THE SALE OF AN OWNER'S PROPERTY.
3. LIMITED TO THREE (3) CONSECUTIVE DAYS **EXCLUDING SUNDAYS AND LEGAL HOLIDAYS.**
4. HOURS OF SALE SHALL BE BETWEEN 9:00 A.M. AND 6:00 P.M.
5. PROPERTY SHALL BE OFFERED FOR SALE OR DISPLAYED ONLY WITHIN THE INTERIOR OF THE RESIDENCE WHERE THE SALE IS TO TAKE PLACE OR TO THE REAR OF THE FRONT BUILDING LINE OF SUCH RESIDENCE. **NO PROPERTY SHALL BE DISPLAYED IN THE FRONT OR SIDE AREAS OF ANY PREMISES.**
6. THE GARAGE SALE PERMIT MUST BE POSTED ON THE PREMISES IN A CONSPICUOUS PLACE.
7. PROPERTY BEING SOLD **MUST BE OWNED BY THE PERSON(S) CONDUCTING THE SALE AS THEIR OWN PERSONAL PROPERTY AND UTILIZED OR MAINTAINED AT THEIR PLACE OF RESIDENCE.** TENANT(S) MUST HAVE WRITTEN PERMISSION FOR A SALE FROM THE HOMEOWNER.
8. ONE (1) SIGN, NOT LARGER THAN TWO (2) FEET SQUARE **MAY BE INSTALLED ON THE PROPERTY OF THE SALE NOT MORE THAN TWENTY-FOUR (24) HOURS PRIOR TO THE SALE AND MUST BE REMOVED AFTER COMPLETION OF THE SALE. NO SIGN SHALL BE PLACED ON THE PUBLIC RIGHT-OF-WAY OR ON PROPERTY OTHER THAN WHERE THE SALE IS BEING CONDUCTED.**
9. IF A GARAGE SALE IS NOT HELD DUE TO INCLEMENT WEATHER ON THE DATE(S) FOR WHICH THE PERMIT IS ISSUED OR IS TERMINATED DURING THE FIRST DAY OF THE SALE, AN AFFADAVIT BY THE PERMIT HOLDER TO THIS EFFECT SHALL BE SUBMITTED TO THE VILLAGE CLERK WHO MAY ISSUE ANOTHER PERMIT. **NO ADDITIONAL FEE, IF HELD WITHIN THIRTY (30) DAYS.**
10. PENALTY FOR VIOLATION OF THIS LOCAL LAW SHALL BE A SUM OF MONEY NOT EXCEEDING \$250.00 OR IMPRISONMENT FOR A PERIOD NOT EXCEEDING FIFTEEN (15) DAYS FOR EACH SUCH OFFENSE; OR BY BOTH SUCH FINE AND IMPRISONMENT.
